#### **GENERAL MANAGER'S REPORT:**

(It's Miller Time!)

#### Office/Shop

During January, there were approximately 179 work orders completed, 13 meetings, 1 holiday, 1 birthday and our AGM was held. There were also a number of cupboards installed, floors done, a few bathrooms repaired/replaced, and locks replaced/repaired.

During the AGM 4 new Board members were elected. I would like to welcome them all and thank everyone involved in the election process.

#### **Volunteers/Youth Engagement**

The Committees and the Board have still listed engaging the youth in SMHC as a priority. There has been a youth survey and work is still ongoing with regards to implementing some of the suggestions. Difficulties do come from attendance and mentoring so we are looking at different ways to remedy these hurdles.

Through discussions with Members and Committees it seems a lot of the reason why things may stall in SMHC is due to a lack of communication. This includes problems we have been having with youth engagement and other programs we would like to have at SMHC. We will be working on this going forward.

One suggestion we would like to work on going forward is a change in the idea of what volunteering means in SMHC. Being on a committee has been the main focus of our volunteering structure for many years and at times we forget that other ways of volunteering are just as helpful. Event volunteers, members that work the kitchen or sign up desks at meetings, and those that deliver the newsletter are all examples of members volunteering. Volunteering outside a committee helps the community as a whole and may be a way for those that cannot commit to some of the greater time requirements that a committee might require.

Going forward there will be some requests for volunteers in different capacities. Examples will include things like a call for volunteers to help care for the garden in "H", or water trees, seniors' events, more youth initiatives and requests to share your expertise with other members in different capacities. Please keep an eye on the newsletter and any flyers for more information.

#### **Flooring**

There have been a number of questions about flooring lately, and a lot of misinformation being shared among the membership. It is understandable when things change that there may be some details that are missed.

Currently SMHC standards for flooring are laminate on the main floor excluding the living room. A couple of years ago we were faced with the issue of finding a solution to a problem with deteriorating floors caused by nails. When our linoleum is installed there is also subflooring placed under the linoleum. This subflooring is nailed into place and over the years of replacement has caused enough damage that a change was needed. With laminate this damage does not occur and keeping in mind the membership request to look at upgrading the products SMHC uses the decision was made following standard procedures.

Laminate has always been considered an upgrade and in the past if a member wanted laminate in their unit they would pay the upgrade cost. Laminate is still considered an upgrade in the living room, bedrooms, on the stairs and upstairs hallways. When your unit comes up for replacement if you choose to have laminate throughout your unit, you will be charged an upgrade cost. The nail damage is not caused when laying carpet so there was no need to change the standards for areas of the unit that are carpeted at this time. Committees will be looking at different types of carpet in the future.

#### What is an Emergency?

It has been noticed that some clarification around what is considered an emergency is needed. The following are examples that we hope will help:

- Locks: If a member locks their keys in the unit after hours and they can't get in, they need to call a locksmith. If there is an issue after hours with the door handle being broken, not working, etc. please call the emergency maintenance line.
- **Dripping Pipes:** if you have a water pipe dripping periodically (one drip every 20 minutes or so) call in a regular work order the next business day. If you have water leaking in a constant stream whether it be from your taps or the pipe under the sink or in the basement call the emergency maintenance line.
- **Furnace:** if your furnace is off and not working after hours especially in the winter, call the emergency maintenance line.
- **Hot Water Tank:** for hot water tank leaks that you cannot control after hours, call the emergency maintenance line.
- **Sewer Backup:** call the emergency maintenance line.
- **Plugged Sink or Toilet:** stop using the plugged sink or toilet after hours, call the office and submit a regular work order the next business day. NOTE: if you are in a small 3 bedroom unit and have a plugged toilet that you cannot unplug with a plunger, call the emergency maintenance line.

Reminder: for after-hours maintenance emergencies call 403-813-2783.

In closing I would like to encourage all of you to send any suggestions, questions or comments about volunteering opportunities, ways to engage our members, ways to work with other cooperatives, or topics you would like to see clarified to the office. The membership, committees and Board of Directors are all working hard to ensure Sarcee Meadows has a bright future.

#### **ECO ALLEY – NEWS YOU CAN USE**

**DID YOU KNOW?** Composting of **organics** has a huge impact on our carbon footprint as well as our local environment. For this reason, The City of Calgary has expanded recycling and **organic** waste bylaws which will affect all **multi-family residences as well as all businesses.** This new bylaw will take affect **November 1, 2017.** Sarcee Meadows residents have been doing a great job of recycling other recyclables over the years. Now we have to think; recycling organics.

Those Sarcee Meadows residents who have been composting their food and yard waste in a composter and using the final product in their gardens are well on their way to reducing a small portion of the carbon footprint.

**DID YOU KNOW?** The City of Calgary has a goal to recycle or divert 80 percent of all the waste currently placed in Calgary landfills by 2020?

**DID YOU KNOW?** The City of Calgary sells subsidized backyard composters for only \$25.00, tax included (this is a \$100 value). Composters are available year round from: The City of Calgary Online Store at <a href="https://www.calgary.ca/onlinestore">www.calgary.ca/onlinestore</a> or at Clean Calgary Association's Eco Store 809 Fourth Ave. S.W. Call (403) 230-1443 for availability



Composters will be readily available in the spring from all Hardware Stores as well as Green Calgary (#100, 301 14th St NW Calgary, Alberta 403-230-1443)

Composters are approved for use in Sarcee Meadows. The Home Improvement Procedures state that compost bins must be in a fenced or hedged yard. The member is responsible for ensuring that the bin is maintained in a manner so that there is no smell, insect, or rodent problems created by the compost bin.

Perhaps we have to take a look at our own **food waste practices** to reduce the amount that we do waste or throw away:

**PREVENTABLE FOOD WASTE IS:** Food that could have been eaten was thrown away or composted.

**UNPREVENTABLE FOOD WASTE IS:** Food waste that **cannot** be consumed such as: shells, bones, peelings.

**MISFIT VEGETABLES AND FRUIT: Weird** looking fruits and vegetables that are still completely edible. (Should be consumed, not thrown away as waste.)

#### **CITY OF CALGARY NOISE BYLAWS:**

#### **Noise on residential properties:**

In Calgary, citizens have the right not to be disturbed by noise and have the responsibility to not make noise that disturbs others.

Noise can include, but is not limited to, yelling, shouting, loud music, horns, power tools and air conditioners.

#### Under the bylaws, the following cannot be used at night in a residential development:

- (a) a hand lawn mower;
- (b) a motorized garden tool;
- (c) a power tool outside of any building or structure;
- (d) a model aircraft driven by an internal combustion engine of any kind;
- (e) a snow clearing device powered by an engine of any kind except during the 48 hour period following a snowfall, rain or freezing rain;
- (f) a motorized snow or leaf blowing device;
- (g) an outdoor speaker system within 150 metres of a residential development except during the Calgary Stampede

#### These activities are allowed during the "daytime," meaning:

- (i) beginning at 7 a.m. and ending at 10 p.m. of the same day, Monday to Saturday; or
- (ii) beginning at 9 a.m. and ending at 10 p.m. of the same day, Sunday and holidays;

#### Under the bylaws, you cannot cause (or permit to be caused) a continuous sound that exceeds:

- (a) 65 decibels (dBA) measured over a one (1) hour period during the day-time; or
- (b) 50 decibels (dBA) measured over a one (1) hour period during the night-time;

#### Under the bylaws, you cannot cause (or permit to be caused) a non-continuous sound that exceeds:

- (a) 85 decibels (dBA) measured over a period of 15 minutes during the day-time; or
- (b) 75 decibels (dBA) measured over a period of 15 minutes during the night-time;

#### Fines for violations of these regulations range between \$50 and \$200.

#### **Related bylaws:**

The City of Calgary regulates noise through the Community Standards Bylaw 5M2004 part 9. This is an overview of these regulations. Please refer to the actual bylaw for more detailed information. Noise regulations for vehicles can be found in the Traffic Bylaw 26M96. Original copies of bylaws are available at the City Clerk's office.

Eligible applicants may apply for a Noise Exemption Permit.

#### Report a violation:

How to file a complaint and what happens to it

Call Calgary Police Service at (403) 266-1234 if the noise is caused by criminal activity.

Call 311 (from within Calgary) or 403-268-CITY (2489) (from outside Calgary) if the noise is not caused by criminal activity.


