For hundreds of years the people of Treaty 7 region have been building communities on the land known as Moh'kinsstis. The Blackfoot Confederacy (comprising the Siksika, Piikani, and Kainai First Nations), as well as the Tsuut'ina First Nation, the Stoney Nakoda (including the Chiniki, Bearspaw, and Wesley First Nations) and Métis Nation of Alberta, Region 3 have been the protectors of this land. They have made their homes here, shared their stories here, educated their youth and continued their traditions here. Sarcee Meadows is honoured to continue this tradition of creating inclusive communities and to celebrate this territory we now call home.

Buildium: The BUILDIUM App is available! For your convenience download the app to your phone or device and submit inquiries and work orders from anywhere! Just simply search 'Buildium' in the app store, select the 'Resident Center' version of the app, and login with your email address and password. If you need assistance, please email paula@sarceemeadows.coop or call Paula 403-246-2746 ext. 101.



TELUS Fiber Optic: Just a reminder that as part of the installation process for your initial hook up or upgrade to fiber services the TELUS technician will require access to the main panel located in the shop at B50. To ensure that your setup of fiber optic services is successful and smooth please be sure to book the TELUS technician's appointment during our business hours of 8:30-4:30, Monday to Friday. Any other service calls from TELUS that are not related to fiber optic services do not require access to B50.

<u>City of Calgary Noise Exemption for Clearing Snow:</u>

Many people rely on motorized equipment to clear snow, including City crews. Noise restrictions for using such equipment are lifted for 48 hours after a snowfall ends to clear walkways for safety and accessibility. This means anyone is allowed to operate a motorized snow clearing device (including leaf and snow blowers) – at any time of day/night – during that 48-hour window to remove snow and ice. Outside of that window, night use is not permitted.

Bullying, as defined by the National Centre against Bullying in Canada, states that "Bullying happens when someone hurts or scares another person on purpose and the person being bullied has a hard time defending themselves."

Either physically or emotionally, and can happen while at school, in the workplace, in the community, at home or online.

Those bullying often have more social or physical "power". While those targeted have difficulty stopping the behavior.

Bullying is very prominent not only among children, but adults as well. It occurs at any age and in any environment. It is a global phenomenon that takes place wherever human beings are interacting in groups.

It is difficult to understand, that in the 21st century, when people are striving for higher education, professional excellence, with the race of science in nanotechnology, biotechnology, and computer

technology, such a toxic behavior like Bullying is significantly jeopardizing healthy and inclusive interaction among people.

BOXING DAY:

December 26th is known by most people in Canada as Boxing Day (le Lendemain de Noel to our Francophone family) and is associated primarily with a day off work and great deals at the shopping mall!

While this may be true, I was asked by a co-worker what this holiday was all about, and I truly had no idea. After an informal survey of a few friends, family, and clients in my office I discovered that I was not alone in my ignorance. I decided to find the answers and thought it may be fun to share them with everyone.

There are several theories about the origins and meaning of the day. The most consistent of these is that the holiday originated in Great Britain. The purpose was to present gifts of money, food, clothes or other valuable items to servants, tradespeople, and the poor. These gifts were presented in a special Christmas Box along with permission for the employees to take the day off. Boxing Day is still celebrated in a few former British Colonies, each having their own interpretation of the celebration.

Canada, while still quite enthused with the shopping aspect of the day, also celebrates in a more private manner. Boxing Day has become the unofficial day to celebrate with friends. It is also a way to feel included in the festive mood and to celebrate for those Canadians that do not observe Christmas. It is not unusual to be invited to brunch or any number of other social gatherings on this day.

Britain, Australia, and New Zealand call it Boxing Day and celebrate it as a day for sports. Soccer, Rugby, and Cricket are the more popular sports either played or watched on this day.

The Bahamas use Boxing Day as the start of Junkanoo, a weeklong festival lasting until New Year's Day. It is believed that during the time of slavery this was the one day that people were given a break from their forced labour and allowed to celebrate African traditions. Today, the Junkanoo festival includes elaborate costumes, parades, street parties and music.

The Irish celebrate the same date, December 26th, but it is called St. Stephen's Day or Wren Day. The tradition here is that people dress up in straw costumes and parade a fake bird on top of a decorated pole. The legend is that the Wren is said to have betrayed Irish soldiers in olden times. To avoid bad luck, homes and businesses give out money and treats to the costumed people. Some parts of Newfoundland and Labrador still celebrate the traditional Wren Day.

I think that with our Cultural Mosaic and the "loose" interpretations of Boxing Day that in Canada we could call this our Universal Holiday? No matter what race, religion, or belief system you choose to follow everyone can celebrate Boxing Day! Maybe just one small step towards a more tolerant and inclusive society? Just a thought to ponder.

I hope I was able to inform and entertain a few of you with these fun facts.

Paper Snowman Luminaries in 3 Minutes:

Supplies

- 1 sheet of white copy/printer paper
- Black and orange markers crayons or colored pencils
- Tape
- Scissors
- LED tea light candle

Instructions

- 1. You can use plain printer or copy paper, or if you have drawing paper or construction paper, that works too! I used markers, but crayons and colored pencils will do the job as well.
- 2. Fold paper in half lengthwise. Open up and cut along the crease. You can get two luminaries from one sheet of paper.
- 3. Use the markers to draw a snowman face in the center of the paper.
- 4. Make as many as you like! Try different mouths and noses for variations.
- 5. Tape the two ends of the paper together to form a cylinder. Place an LED tea light on the table and set your paper luminary over the top of the tea light. Done!



Expert Tips & FAQs

Push the LED tea light to the front of the luminary so that it's just about touching the paper. LED tea lights are not nearly as bright as a real candle, so getting them closer to the paper will help the light shine through.
